Fall Board National Meeting Up-Date

Senators:

This is a report on the Fall Board National Meeting in Denver, Colorado.

The membership in the US JCI Senate is 8117 and the raffle ticket sales are at \$29,000 so far.

Wreaths Across America is a new program for States to participate in. It is on December 17 and wreaths are laid on Veterans' graves. Something to think about for next year!

Reports were given on Fall Boards in Golden, CO, the winter board meeting in Kenner, LA hosted by the Iowa Senate January 17-23, 2023 and the National meeting in St. Louis, MO June 2023.

There were 353 Senators at the 50th anniversary in Louisville, KY in June and 408 at the year-end banquet on Thursday night.

The next Fall Board meeting will be in Houston, TX Sept 21-23, 2023.

SD was tied for 1st place at plus 7 for growth for the first quarter June 1 thru September 1. The next dues deadlines are December 1st, March 1st and June 1st.

Reports were given by all 10 the National Region VP's, all Program Managers, Chair people and meeting coordinators, legal counsel, and USJCI Senate Foundation.
